Coimisiún na Meán

The media regulator Coimisiún na Meán was established on the 15th March 2023 further to the provisions of the Online Safety and Media Regulation Act 2022, and replaces the Broadcasting Authority of Ireland. An Coimisiún will continue to deliver the functions of the former BAI, including the licensing of radio and television services, the development of codes and rules in relation to programming and advertising standards, and administration of the Broadcasting Funding Scheme. In addition Coimisiún na Meán will begin establishing a regulatory framework for ondemand audiovisual services and online safety, and will undertake a media development role.
